

SPECIAL ELECTION FOR TOWN OF STAR CITY

An election to authorize the Town of Star City to move the Town of Star City's regular election for the choice of a Mayor and a Recorder, and for the choice of the members of the common council, to the Monongalia County, West Virginia ballot occurring on the same day as the regularly scheduled statewide primary election beginning with the election to be held in the year 2024; and furthermore, authorizing the change in the term of office for Mayor, Recorder and the members of the common council elected at the municipal of office for Mayor, Recorder and the members of the common council elected at the municipal election in the Town of Star City in 2023, to a one year term of office ending June 30, 2024, for the purpose of aligning the terms of office for Mayor, Recorder and the members of the common council to coincide with the change in the date of the Town of Star City election, and thereafter the terms of office for Mayor, Recorder and the members of the common council beginning with their election on Monongalia County's primary election ballot in 2024 shall return to a two year term of office effective July 1, 2024. \bigcirc For \bigcirc Against
