Amendment No. 1: Clarification of the Judiciary's Role in Impeachment Proceedings Amendment

MONONGALIA COUNTY COMMISSION SPECIAL ELECTION TO AUTHORIZE ADDITIONAL LEVY

FOR STATE SENATOR 2ND SENATORIAL DISTRICT (Vote For ONE)

Summary of Purpose: Clarifying that courts have no authority or jurisdiction to intercede or intervene in or interfere with impeachment proceedings of the House of Delegates or the Senate; and specifying that a judgment rendered by the Senate following an impeachment trial is not reviewable by any court of this state.

Election to authorize a levy for the fiscal years beginning July 1, 2023, 2024, 2025, and 2026 for the purpose of contributing funds from such levy for emergency medical services for the acquisition of equipment and other capital improvements, payment of a portion of general operating, maintenance, and other expenses in the amount of approximately \$4,470,399 annually and \$17,881,598 during the term of the Levy. The need for such funding has been determined by the Order of the County Commission of Monongalia County, West Virginia entered on the 20th day of July 2022.
