Amendment No. 1: Clarification of the Judiciary's Role in Impeachment Proceedings Amendment

Election to authorize a levy for the fiscal years beginning July 1, 2023, 2024, 2025, and 2026 for the purpose of contributing funds from such levy for emergency medical services for the acquisition of equipment and other capital improvements, payment of a portion of general operating, maintenance, and other expenses in the amount of approximately \$4,470,399 annually and \$17,881,598 during the term of the Levy. The need for such funding has been determined by the Order of the County Commission of Monongalia County, West Virginia entered on the **20th** day of **July 2022**.
